



REFERRAL PROGRAM - TERMS AND CONDITIONS

1stScholar a Test assessment and preparation platform run and managed by M/s TechQuint Services & Consulting Pvt. Ltd, a company having CIN U74999HR2016PTC066890 and incorporated under the Companies Act, 2013, and having its registered office at 554, Urban Estate – II, Hisar, Haryana – 125005 (hereinafter referred to as “**COMPANY**”) is running a Referral Program (hereinafter referred to as “**PROGRAM**”) to invite legitimate users directly or indirectly to their website, mobile application or online platform (hereinafter referred to as “**PLATFORM**”) through its registered users (hereinafter referred to as “**REFERRER**”).

Referral Program: This referral program is a “Refer a Friend” program that company encourages its registered users to tell other people about the platform and invite them to register with us.
